SIMPLIFIED PARISH PLAN 2009 - 2019

Revised Update and Action Plan to November 2013

Approved at the Parish Council Meeting on 4th March 2013

This plan simplifies the full plan by removing those actions that have already been achieved and combining similar actions in different priorities or where priorities are co-dependent and therefore need to be developed in parallel. This plan also groups actions into the lead agent responsible for developing them.

It should be noted that all the priorities in this plan will need to refer back to the fuller plan for more details and what conditions (e.g. decision making on the issue lies with someone else) have been attached which may affect the outcome of the action or how it can be progressed.

Key to Roles of Parish Council (PC)

- A = Active action needed
- L = Lobbying resources or decision-making is at County level or elsewhere, and we would need to promote the priority to appropriate bodies
- M = Monitoring no action needed or possible, but would watch closely new developments or changes that could affect the progress of the priority and respond accordingly
- S = Supportive action being taken by another organisation, but will require financial or personal support from PC
